

## **ADDX New Investor Rewards Program (“Promotion”)**

Version Date: 8 October 2025

### **Terms and Conditions**

This Promotion is organised by ADDX Pte. Ltd. (“ADDX”) and is valid from 8 October 2025 (00:00 SGT) to 31 December 2026 (23:59 SGT) (both dates inclusive) (“Promotion Period”). If a Participant completes tasks between 8 October 2025, 00:00 SGT and 15 January 2026, 23:59 SGT (both dates inclusive), the Participant will qualify for the special “Boosted Promotion Period”.

These terms (“Promotion Terms”) supplement the Platform Terms and Conditions and Exchange Rules. All terms used herein shall have the same meanings ascribed to them in the respective aforementioned terms and conditions, unless otherwise defined herein. By participating in this Promotion, a Participant agrees to and is bound by these Terms. For the avoidance of doubt, the ADDX Rewards Programme Terms and conditions shall also apply and is binding on the Participant. Please refer to the ADDX Website for further information.

### **Reward Tasks**

#### **1. Sign Up (“Task 1”)**

- 1.1 This Promotion is open to new participants who have applied for a trading account on the ADDX Platform and whose trading account is valid and subsisting (“**Participant**”) and have successfully become a Participant on or before the expiry of the Promotion (“**New Participant**”).
- 1.2 New Participants who have successfully opened a trading account on ADDX Platform, are eligible to be awarded in the following manner:
  - 1.2.1 Promotion Period – ADX\$38.
  - 1.2.2 Boosted Promotion Period – additional ADX\$50 totalling ADX\$ 88.
- 1.3 The ADX\$ will be issued upon successful activation of a ADDX trading account.
- 1.4 Sign Up Rewards are available only to new Participants who have not previously signed up for a trading account.
- 1.5 ADDX reserves the right to verify all account sign-ups and disqualify duplicate or fraudulent entries.
- 1.6 All other standard terms and conditions of the ADDX Rewards Programme apply.
- 1.7 All issuance of ADX\$ are further subject to the Miscellaneous Terms and Conditions set out below.

#### **2. First Investment (“Task 2”)**

- 2.1 This Promotion is open to all (1) New Participants sign-ups; and (2) existing Participants who have yet to make any trades on the ADDX Platform (each a “**Dormant Participant**”).
- 2.2 Participants are eligible for this reward upon the successful completion of their subscription of an offering of new security tokens issued on the ADDX Platform in the following manner:

- 2.2.1 Promotion Period – ADX\$38.
- 2.2.2 Boosted Promotion Period – additional ADX\$30 totalling ADX\$68.
- 2.3 To qualify for this Promotion, the eligible investment must be a subscription for an offering of new security tokens issued on the ADDX Platform, but for the avoidance of doubt, does not include (i) buy trade(s) on the ADDX Platform; and (ii) sell trade(s) on the ADDX Platform.
- 2.4 Limited to one reward per Participant.
- 2.5 All other standard terms and conditions of the ADDX Rewards Programme apply.
- 2.6 All issuance of ADX\$ are further subject to the General Terms and Conditions set out below.

### **3. Three (3) different investment (“Task 3”)**

- 3.1 This Promotion is open to all New Participants and Dormant Participants.
- 3.2 Participants are eligible for this reward upon the successful completion of three (3) different investments on the ADDX Platform in the following manner:
  - 3.2.1 Promotion Period – ADX\$88.
  - 3.2.2 Boosted Promotion Period – additional ADX\$30 totalling ADX\$118.
- 3.3 To qualify for this Promotion, the eligible investment must be a subscription for an offering of new security tokens issued on the ADDX Platform, but for the avoidance of doubt, does not include (i) buy trade(s) on the ADDX Platform; and (ii) sell trade(s) on the ADDX Platform.
- 3.4 Limited to one reward per Participant.
- 3.5 All other standard terms and conditions of the ADDX Rewards Programme apply.
- 3.6 All issuance of ADX\$ are further subject to the General Terms and Conditions set out below.

### **4. Accumulated Investments (“Task 4”)**

- 4.1 This Promotion is open to all New Participants sign-ups and Dormant Participants.
- 4.2 Participants are eligible for this reward upon the accumulation of total investment of SGD30,000 (or equivalent) in the following manner:
  - 4.2.1 Promotion Period – ADX\$118.
  - 4.2.2 Boosted Promotion Period – additional ADX\$40 totalling ADX\$158.
- 4.3 To be eligible for this promotion, the eligible investment must be a subscription for an offering of new security tokens issued on the ADDX Platform, but for the avoidance of doubt, does not include (i) buy trade(s) on the ADDX Platform; and (ii) sell trade(s) on the ADDX Platform.

- 4.4 Limited to one reward per Participant.
- 4.5 All other standard terms and conditions of the ADDX Rewards Programme apply.
- 4.6 All issuance of ADX\$ are further subject to the General Terms and Conditions set out below.

- 5.2 Participants are eligible for this reward upon the completion of successful referral using their Referral Code (as defined in the [ADDX Promo Terms and Conditions]).

- 5.3 To qualify for this reward, Participants must invite a new user using their unique invite Referral Code which they can generate from their ADDX trading account. For both parties to receive the Rewards as a successful referral, the referee must complete the account verification and comply with the terms as set out in the ADDX Promo Terms and Conditions]. Please refer to ADDX Promo Code for more information.
- 5.4 For the avoidance of doubt, even if the referral process was initiated during the Promotion Period, but the process was not completed during the Promotion Period, the Participant will not be eligible for this reward. Furthermore, even if the referral process was initiated during the Boosted Promotion Period, but the process was not completed during the Boosted Promotion Period, the Participant will not be eligible for the additional ADX\$ for the Boosted Promotion Period. However, the Participant will be eligible for the ADX\$ reward for the Promotion Period provided the referral process was completed during the Promotion Period.

- 5.4.1 For illustration purposes:

### Scenario 1

Referee signs up with Referrer's unique promo code on 10th January 2026 (during the Boosted Promotion Period). Referee's account activation was successfully completed on 14th January (during the Boosted Promotion Period). Referrer will receive ADX\$218 and Referee will receive ADX\$88.

### Scenario 2

Referee signs up with Referrer's unique promo code on 10th January 2026 (during the Boosted Promotion Period). Referee's account activation was successfully completed on 20th January (after the Boosted Promotion Period). Referrer will receive ADX\$156 and Referee will receive ADX\$88.

- 5.5 All other standard terms and conditions of the ADDX Rewards Programme apply.

- 5.6 All issuance of ADX\$ are further subject to the General Terms and Conditions set out below.
- 5.7 There is no limit to the number of people a Referrer can refer, however ADDX reserves the right to disqualify referrals deemed fraudulent or abusive.

## 6. Milestone Accomplishment ("Task 6")

- 6.1 This Promotion is open to all New Participants and Dormant Participants.
- 6.2 Participants are eligible for this reward upon the completion of the following tasks as set out in the table below:

## 8. How to Claim

8.1 Upon completion of a task and to receive the reward, Participants must visit the Rewards section in the ADDX Platform and click "Claim". Provided that the Promotion terms and conditions are met, the reward will be reflected in the Participant's trading account after the claim is successfully made.

## **9. General Terms and Conditions**

- 9.1 All terms used herein shall have the same meanings ascribed to them in the ADDX Rewards Programme's terms and conditions, ADDX Platform Terms and Conditions and ADDX Exchange Rules, unless otherwise defined herein.
- 9.2 To be entitled to ADX\$ under this Promotion, a Participant shall:
  - 9.2.1 fulfil the qualifying criteria and meet all the requirements as set forth in the Promotion; and
  - 9.2.2 remain in compliance with all other prevailing terms and conditions of ADDX.
- 9.3 Participants who are found to be in breach of any such prevailing terms and conditions of ADDX may, at the ADDX's discretion, forfeit all accrued ADX\$ and/or their eligibility to participate in the ADDX Rewards Programme.
- 9.4 ADX\$ will not be credited into the Participant's ADDX trading account, until:
  - 9.4.1 the Participant's successful completion of the specific Promotion is determined by ADDX to be valid; and
  - 9.4.2 the Participant has gone to the Event page and manually click the claim button.
- 9.5 ADDX may cancel and/or delete and/or otherwise deduct ADX\$ that have already been credited into the Participant's trading at their absolute discretion, including under the following circumstances:
  - 9.5.1 ADX\$ claimed in breach of any of these Promotion Terms and/or any other prevailing Terms and Conditions; and/or
  - 9.5.2 ADX\$ erroneously awarded due to system or computer glitches or any other reasons or errors or omissions.
- 9.6 ADX\$ has no cash value. ADX\$ are not redeemable for cash and are not transferable or assignable for any reason or any purpose. ADX\$ are not transferable between ADDX trading accounts. The sale, transfer, or assignment of any accrued ADX\$ is strictly prohibited, and any ADX\$ which ADDX deems at its absolute discretion to have been transferred, sold or assigned in violation of these Promotion Terms may be confiscated, deleted, forfeited and/or cancelled.

## **10. PERSONAL DATA**

- 10.1 It is a continuing condition of the Participant's use of the ADDX Platform and participation in the Promotion, as well as their access to and use of the ADDX Platform that the Participant agrees to and consents that ADDX may collect, use and disclose such Participant's personal data as provided in the registration of their ADDX Platform, to its affiliates, service providers and partners, for the following purposes in accordance with the PDPA and ADDX's privacy policy available at ADDX Website:

- 10.1.1 to administer and manage this Promotion, including to contact the Participant and to conduct verification and other actions in connection with this Promotion for the processing the Participant's ADX\$ accruals; responding to the Participant's queries, requests and feedback;
  - 10.1.2 informing the Participant of changes and development to ADDX Rewards Programme and/or our policies, terms and conditions and other administrative information, including for the purposes of providing the products and services to the Participant; and
  - 10.1.3 conducting market research and/or analysis, carrying out surveys, improving customer service, managing, improving and enhancing the products and/or services of ADDX.
- 10.2 If a Participant requires access to their personal data, make any amendment or correction to their personal data, or wishes to withdraw consent to any specific use of their personal data, the Participant should email ADDX at [dpo@addx.co](mailto:dpo@addx.co).
- 10.3 The Participant acknowledges that if they choose to withdraw their consent for the collection, use and/or disclosure of their personal data, ADDX may not be able to continue providing the Participant with the products, services, promotions or benefits under the ADDX Rewards Programme.

## **11. Miscellaneous**

- 11.1 The Participant agrees to be bound by these Promotion Terms and all other terms and conditions governing the use of such services or benefits in connection with the ADDX trading account, including but not limited to such terms and conditions as ADDX may stipulate, issue or publish from time to time in relation to any promotions, campaigns or programmes that ADDX may undertake or carry out from time to time, as the same may be amended or varied from time to time by ADDX. In the event of any inconsistency between these Promotion Terms and any other terms and conditions, these Promotion Terms shall prevail.
- 11.2 ADDX reserves the right, at its sole and absolute discretion and without needing to provide any reason or notice, to:
- 11.2.1 determine that any condition and/or requirement entitling any Participant to ADX\$ has not been fulfilled;
  - 11.2.2 not credit any ADX\$ to a Participant notwithstanding that the Participant has otherwise fulfilled the other requirements set out in these Promotion Terms to be credited with ADX\$.
- 11.3 ADDX shall not be required to inform any Participant whether such Participant is eligible for any entitlement to ADX\$.
- 11.4 ADDX reserves the right to delay reward distribution in cases of processing issues.
- 11.5 ADDX shall not be liable for any delay in crediting the ADX\$ to any Participant.
- 11.6 ADDX reserves the right to end or modify the Promotion at any time without prior

- 11.7 Under no circumstances whatsoever shall ADDX be liable for any indirect, punitive, incidental, special or consequential damages that result from, or arise out of the usage of any information stated herein or the participation in the ADDX Rewards Programme.
- 11.8 Notwithstanding any other terms and conditions in these Promotion Terms, each Participant agrees to:
- 11.8.1 release ADDX, its related corporations, affiliates, suppliers, advertising, and promotions agencies and their respective directors, officers, employees, and agents from any and all liability arising from any loss, harm, damages, cost, or expense, including without limitation, any property damages, personal injury and/or death, arising out of or in any way connected to any Promotion, and waives any claim to the same; and
  - 11.8.2 indemnify, defend, and hold ADDX, its related corporations, affiliates, and their respective representatives, directors, officers, employees, and agents harmless from and against any and all third party claims, demands, liabilities, costs, or expenses, including attorney's fees and costs, arising from, or relating to any breach of any of these Terms or any violation of applicable laws, rules and regulations.
- 11.9 Taxes. ADDX\$ may be taxable depending on the country, state, and/ or local tax laws applicable to the Participant. Participants are solely responsible for reporting such items in their tax returns and paying any associated tax(es) and liabilities.
- 11.10 Although ADDX will use reasonable efforts to notify Participants of material changes to the ADDX Rewards Programme, it is the responsibility of Participants to keep themselves up to that. Any use of the ADDX Rewards Programme will be deemed as acceptance of any amendment.
- 11.11 ADDX may terminate or suspend, amend or update these Promotion Terms, in its sole and absolute discretion, at any time without providing prior notice.
- 11.12 Any determination made by ADDX in respect of all matters relating to this Promotion shall be at its sole and absolute discretion and shall be final, conclusive and binding on all Participants.
- 11.13 This Promotion Terms are governed by the laws of Singapore. Any dispute arising from these Terms are subject to the exclusive jurisdiction of the courts of Singapore.
- 11.14 A person who is not specified in these Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce any term of these Terms.
